



## Bucks County Gallery 6 x 6 Exhibit and Sale

### Event Details

The Bucks County Gallery 6 x 6 Exhibition and Sale is being hosted at the Bucks County Gallery of Fine Art located in New Hope PA. The show will feature nationally recognized artists painting traditional, representational, and plein air oil paintings, watercolor, pastel, & acrylic works. landscape, still life, figurative, nudes, animals, beach scenes, street scenes, architectural, and portraits are all acceptable. Call with questions regarding subject matter. Artists can submit up to six paintings. The **paintings must be framed in at minimum a 1 1/2" wide frame** to present the artwork properly. The gallery reserves all rights to reject any art that is not appropriately framed and in good condition. All work submitted must be for sale. Only three paintings by any artist will be displayed at a time, your additional paintings will be hung as others are sold.

Pastel & watercolors must be framed behind anti reflective glass similar to Tru Vue Museum or AR glass. **Non glare glass is not acceptable.** The gallery will hang as many as three paintings by each artist. **Entry deadline is Monday October 28, 2013.** Artists accepted to the show will be notified by on or by **Tuesday November 5, 2013.** Accepted work must be received at Bucks County Gallery no later than **Monday November 18, 2013.**

### Qualification Requirements

Any artist living in the Continental United States and Canada are qualified to submit art. The art must be traditional and representational. **The art must have been painted in the past 12 months - no exceptions.**

### Entry Fee

The \$40.00 entry fee includes up to three paintings per artist. A fee of **\$10.00 per painting** is charged for an additional three paintings if you choose to send more. Checks are to be payable to Bucks County Gallery, with your CD. No refunds once your entry is received.

### Commission

Bucks County Gallery will retain 40% commission for all sales and reserves the right to allow a 10% discount in order to generate a sale. The discount is shared between the artist and gallery.

### Selection Committee

Artwork being accepted will be the decision of the Bucks County Gallery selection committee and all decisions are final.

### Entry Guidelines

Send us a CD with your images in JPEG format that are 350DPI at 6 inches. No other format is acceptable. Entries via email can be arranged in certain circumstances. Please call us with any questions or if you need assistance.

### Prizes

There will be \$2000.00 in cash awards as follows: Best of show \$1000.00, First Place \$500.00, Second Place \$300.00, and Third Place \$200.00.

**Damage**

The artist agrees not to hold Bucks County Gallery liable for any loss or damage of their art or frames. All art will be handled as carefully as possible by the gallery and their representatives. By submitting your art to the show, you agree to this clause.

**Shipping**

The artist is responsible for shipping to and from the gallery. You must include a return shipping label with your entry form and check.

Accepted work notifications - November 5, 2013

Art must be received by November 18, 2013

Exhibit and Sale - November 29 - December 30

Artwork Pick up - No later than January 10th, 2014
